Madam/Sir,

In inviting a reference to the letter on the subject cited above, I am directed to inform you that, the dateline for collection of admission fees from First Year U.G. & P.G. students (Freshly admitted in Phase-I & II admission process) for the session 2022-23 was enabled till 15.11.2022. It may be stated here that, currently, the P.G. vacant seat admission process is going on in offline mode and the process will continue till 25.11.2022.

Therefore, it is hereby informed that, the **final dateline** for collection of admission fees at the admitted Higher Education Institutions for both U.G & P.G. Students has been extended up to **30.11.2022**. Students, who will be finally admitted after all phases of admission, will have to deposit their admission fees by 30.11.2022 directly at the admitted HEIs in online mode (Bank Transfer/Net Banking/Bank Challan/NEFT) only. **The non-payment of admission fees within the dateline will lead to cancellation of admission.** No more extension of dates will be entertained at this end at any circumstances.


